



FIXED PRICE UNIFORM DISCLOSURE STATEMENT (RESIDENTIAL)

The services provided to you by **MC Squared Energy Services** are governed by the Residential Electric Supply Agreement and Terms and Conditions of Service. Below is a summary of some of the important details about your switch to MC Squared Energy Services.

Retail Electric Supplier (RES)	Electricity Supply Services will be provided by MC Squared Energy Services, LLC (“MC Squared” or “mc ² ”).

Service Offer	Electricity supply services for your residence.
MC Squared Charges	The charges for power and energy are calculated for you based on your electric historical electric power usage and the term of your agreement. The MC Squared charges are listed in the Price Confirmation section of your MC Squared Agreement. All ComEd distribution charges and applicable taxes will be the same regardless of your power and energy service supplier.
Term of Agreement	The term of the agreement will begin with the first billing cycle after your rate change is confirmed with ComEd and continues for the term documented in the MC Squared Agreement. Contract terms available include 12 and 24 months.
Renewal Policy	<p>Unless otherwise specified, mc² will send an electronic notice to the email address provided at least 30 but not more than 60 days prior to the initial contract end date for one of the following options:</p> <ul style="list-style-type: none"> a) Automatic Renewal Notice or New Contract Notice: If mc² decides to renew or extend this agreement, the renewal notice will offer to extend the Customer’s contract at a specified market price and term. THE CUSTOMER MUST PROVIDE NOTIFICATION TO CANCEL THIS RENEWAL OFFER WITHIN 30 DAYS OF THE RENEWAL NOTICE DATE. AFTER 30 DAYS, THE RENEWAL OFFER WILL BE DEEMED ACCEPTED, AND THE CUSTOMER’S CURRENT CONTRACT WILL BE AMENDED ACCORDINGLY. b) Contract Expiration Notice: If mc² decides not to renew or extend this agreement, your account will be returned to ComEd’s bundled tariff rate and you will be responsible for arranging your new electricity supply service. <p>Customers are encouraged to update any changes to their email address through the My Account portal on www.mc2energyservices.com.</p>
Early Termination Fee	There are NO Termination Fees if you terminate the MC Squared Agreement prior to the end of the applicable term. If you terminate your agreement early, you will be obligated to pay for services rendered under the contract until service is terminated.

<p>Deposit</p>	<p>MC Squared does not require a deposit for its service. ComEd, however, may require deposit for its service and will inform you of any such requirement.</p>
<p>Switching Fee</p>	<p>MC Squared does not assess any fee to you for switching to MC Squared.</p>
<p>Rescission Process</p>	<p>You may rescind your agreement with MC Squared prior to enrollment with ComEd. You can also rescind your agreement and the pending enrollment with MC Squared, within ten (10) days after you receive the enrollment notice from ComEd by contacting MC Squared at (855)740-9992 or by contacting ComEd at 1-800-Edison1.</p>
<p>No Savings Guarantee</p>	<p>Due to the price volatility associated with the energy market and ComEd rates, mc² cannot guarantee that your mc² price will be lower than the ComEd rate for any or all billing periods of your contract.</p>
<p>Electric Reliability</p>	<p>ComEd will continue to be responsible for the delivery of power to your residence and will continue to respond to service calls and emergencies. Switching to MC Squared will not impact your electric service reliability.</p>
<p>Sales Agents</p>	<p>MC Squared is an independent seller of power and energy service, and has been certified by the Illinois Commerce Commission. MC Squared sales agents do not represent or act on behalf of your electric distribution service provider (ComEd), any governmental bodies or consumer groups.</p>
<p>Notification</p>	<p>You will receive written notification from ComEd confirming the switch of your electricity supply service to MC Squared.</p>
<p>Usage Data</p>	<p>You authorize mc² to obtain all data necessary so that mc² can enroll your account and take such actions as necessary and reasonable to perform this Agreement, including accessing and using account information and meter usage data (including interval usage data) from ComEd, enrolling account, procuring supply, scheduling and causing electricity to be delivered to your account.</p>
